TERMS OF AUCTION

- 2.) Seller warrants he/she is sole and only owner and has right to sell vehicle and has clear title or consent of lien holder to sell.
- 3.) Titles returned after funds clear bank or cash is received.
- 4.) Seller acknowledges that it is impossible to predict with certainty the prices which will be received for auctioned items. Accordingly, no such representation is made.
- 5.) Seller agrees that the auction company assumes no liability for loss or damage to the vehicle, and seller agrees to save the auction company, their agents, and their employees harmless from any claims for bodily injury or property arising out of said auction sale. Seller to maintain insurance.
- 6.) The auction company shall not be responsible for the failure of any bidders to consummate their purchases or otherwise comply with the terms and conditions of the sale. If Seller sues the auction company but does not obtain judgment, seller shall reimburse the auction company's expenses of defense.
- 7.) Payment is to be made directly from Buyer to Seller.
- 8.) No Reserve cars must be declared "No Reserve" BEFORE at time of consignment to receive "No Reserve" rates and commission.
- 8.) This document contains the entire agreement of the parties and shall be binding on them and their respective heirs, personal representative and assigns. It shall not be modified except in writing, signed by the auction company or at the auction block. This contract shall be interpreted in accordance with the laws of Missouri.
